The CGAP Working group (recently renamed as Microinsurance Network) Technology Subgroup and the Microinsurance Innovation Facility have compiled an inventory of information technologies that are or could be applicable in the extension of insurance services to low-income households. The objectives of the study were to catalogue and illustrate all kinds of technologies used or potentially useable in the area of microinsurance. The areas of the study included data collection, communications, management information systems and services to support microinsurance practitioners and to support capacity building groups working with these organizations.

The workshop's intention is to build on these first milestone and its aim is to discuss the 3 following areas which came out of the Study: 1. Technology Outreach; 2. Microinsurance Data and Workflow Standardization; and 3. Microinsurance Data Repository.

Results of the study and feedback of the workshop shall be presented in the plenary session of the conference on November 7th and the agenda for the Working Group for 2009 will be discussed.
